

Griffith Park



Griffith Park lies directly to the south and west of the Golden State Freeway (I-5) and the Ventura Freeway (SR-134) at the eastern end of the Hollywood Hills in the City of Los Angeles.

The Griffith Park Visitors Center contains educational plant, bird, animal, and geological displays related to the Park. Located adjacent to the Ranger Station at: 4730 Crystal Springs Drive. 323.644.2050

DIRECTIONS

From the South: Take Los Feliz Boulevard, Griffith Park Drive or Zoo Drive northbound off-ramps from I-5

From the North: Take Western Avenue or Los Feliz Boulevard southbound off-ramps from I-5

From the East: Take Zoo Drive or Forest Lawn Drive westbound off-ramps from SR 134.

From the West: Take Forest Lawn Drive or Victory Boulevard eastbound off-ramps from SR 134.

REGULATIONS

Griffith Park is open to the public from 6 am to 10 pm daily. Bridle trails, hiking paths and mountain roads close at sunset. The speed limit on all park roads of 25 mph is strictly enforced.

Brush fires present a definite safety hazard especially when the brush is dry. Smoking and open fires are prohibited although barbecues and stoves are permitted in designated areas.

Bicycles are permitted on all park vehicular roads and on the LA River Bicycle Path. Dogs must be kept on-leash except in designated off-leash areas.

Caution: Griffith Park is a wilderness area with wild rodents, coyotes and rattlesnakes. In case of emergency in the park, notify the Ranger Station at 323.644.6661 or dial 911.
